

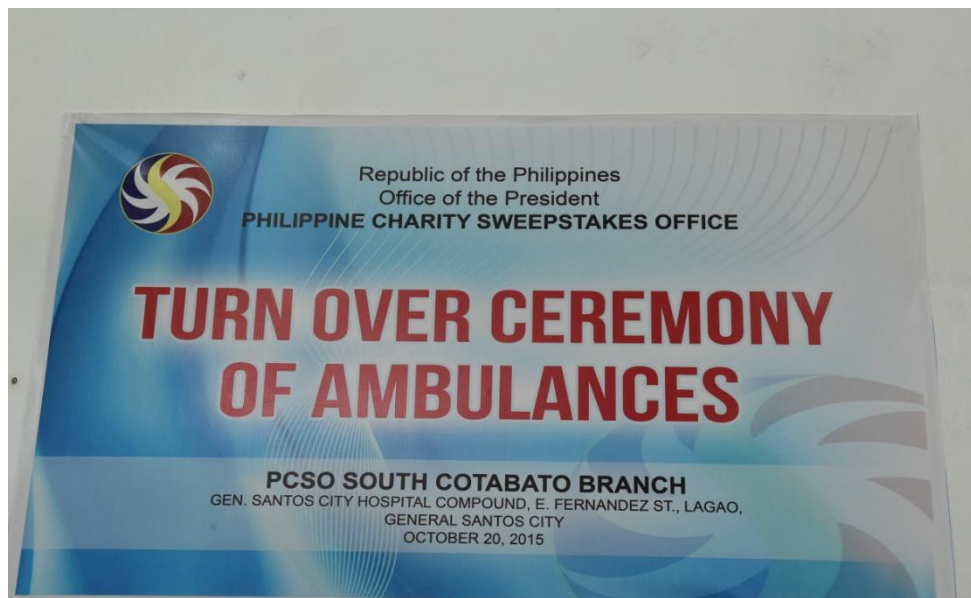
PCSO DONATES 15 AMBULANCES IN GENERAL SANTOS CITY, MINDANAO
