



GROUP ACCOMPLISHMENT REPORT (1stQuarter 2011)

This report features the accomplishments of CIDG from January1 – March 31, 2011 based on the Program Thrust of the Chief, PNP and the 3-Point Agenda of the Director, CIDG.

Several significant accomplishments from the different flagship projects are presented in this report as well as those resulting from the anti-criminality campaigns, which this Group has consistently and religiously implemented and monitored.

Most notable are the neutralization/arrest of several members of notorious OCGs/CGs, most wanted persons and other suspects in high profile crimes.

TheAdministrative, Investigation, Intelligence and PCR accomplishments that contributed much to the Group's success in meeting the expectation of the NHQ are also presented in this report.

Significant accomplishments under CIDG OPLAN "Salikop":

1. NEUTRALIZATION OF "BUNGO" GUN-FOR-HIRE GROUP IN BACOOR, CAVITE

• On March 23, 2011, elements of Cavite CIDT-4ARCIDU of this Group together with Bacoor MPS neutralized the "Bungo" Gun-for-Hire Group after their arrest at Green Valley Subdivision, San Nicolas 3, Bacoor, Cavite. The group has been tagged as the perpetrators in several killings in Bacoor, Cavite including the shooting to death of Sem Hermoso y Infante, a

former CIDG Civilian Agent on March 13, 2011 at Latero, San Nicolas 3, Bacoor, Cavite.

• The said operation was the result of the immediate response of Cavite CIDT personnel on the information received that the said group was seen gambling at Latero Green Valley, San Nicolas 3, Bacoor, Cavite, namely:

- Clary BANAYADO y Rafol @Bungo, 25 years old, alleged leader of the group;
- Arnel BABIA y Berandoy @Arnel, 30 years old;
- Reynaldo DE LEON y Acosta @Rey, 37 years old; and
- Edmond DACUMOS y Garci, legal age.

• Confiscated from their possession were gambling paraphernalia such as playing cards and bet money amounting to Php 300.00. Incidental to their arrest, a fan knife and three (3) pieces of cal.45 ammunition were confiscated from the possession of Reynaldo DE LEON, while yielded from the possession of Clary BANAYADO and Arnel BABIA were two (2) hand grenades. However, one of the arrested person identified as Edmond DACUMOS punched one of the apprehending officers while they were trying to elude arrest.

• In the conduct of investigation, witnesses Samuel Suarez y Elleon and Mamerto Etang Jr. y Pabroquis, both of legal ages and resident of San Nicolas Valley, Bacoor, Cavite, positively identified the arrested suspects and a certain Ronaldo FERNANDEZ (at-large) as the suspects in the shooting to death of Sem Hermoso y Infante on March 13, 2011 inside the cockpit arena located at Latero Green Valley, San Nicolas 3, Bacoor, Cavite using a cal .45 pistol, as narrated in their Sworn Statements.

• On March 24, 2011, a case for violation of PD 1602 was filed against the four (4) arrested persons docketed under IS No. IV-03-11C-1029, while separate cases were filed against Clary BANAYADO and Arnel BABIA for violation of PD 1866 as amended by RA 9518 (Illegal Possession of Hand Grenades) docketed under IS No. IV-03-11C-1030, violation of PD 1866 as amended by RA 8294 (Illegal Possession of Ammunition) against Reynaldo DE LEON docketed under IS No. IV-03-11C-1031 and Direct Assault against Edmond DACUMOS docketed under IS No. IV-03-11C-1032, all before the Provincial Prosecutor's Office, Imus, Cavite. On March 25, 2011, a case of Murder was also filed against the four arrested suspects for the killing of Sem HERMOSO docketed under IS No. IV-03-11C-1035.

2. ARREST OF LEADER OF THE VACUNAWA GROUP IN BRGY. STA. MONICA, SAN PABLO CITY

On March 5, 2011, elements of 4ARCIDU of this Group arrested Arnel P. VACUNAWA by virtue of Search Warrant No. 1918-11 issued by Hon. Cesar Mangrobang, Judge of RTC, Branch 22, Imus, Cavite for violation of PD 1866 as amended by RA 8294 at Brgy. Sta. Monica, San Pablo City, Laguna. Subject arrested person is the leader of VACUNAWA Group and the principal suspect in the robbery/hold-up incident that transpired on February 11, 2011 along Brgy. San Roque Road,



San Pablo City that resulted to the killing of Mrs. Maria Luisa Landicho, Secretary of CGF Company and the wounding of Manolo Moreno, the Company Driver.

• Arnel VACUNAWA and his group are known for its notoriety in staging robbery/hold-up heist in Rizal Province and the subject of COPLAN of Rizal CIDT with operational area in Tiaong, Quezon and Batangas province. The said group is believed to have a hand in the robbery incident last March 3, 2011 in Rosario, Batangas that carted loot amounting to Php300,000.00. Likewise, VACUNAWA is also included in the robbery/hold-up incidents at aforesaid municipality.

 A case for violation of RA 8294 (Illegal Possession of Ammunition) was filed against arrested suspect before the San Pablo Prosecutors Office docketed under NPS No: IV-18-INQ-11C-00041, which shall be incorporated with the Robbery with Homicide case filed against the same suspect and his cohorts last February 28, 2011 docketed under IS No. IV-IP-INV-IIV-00099.

3. ARREST OF SUSPECTS INVOLVED IN THE ROBBERY OF JEWELRY AND PAWNSHOP IN GAISANO MALL, TAGUM CITY

On February 21, 2011, elements of 11RCIDU of this Group together with Tagum CPS, Davao del Norte PPO and 1stPlatoon Davao del Norte PPSC implemented Warrant of Arrest in CC No. 17606 issued by RTC Branch 31, Tagum City for the crime of Robbery that resulted to the arrest of Christopher LLEDO, 30 years old, single, a resident of Purok 7, San Antonio, Mabini, Comval Province.

 Subject person was tagged as one of the suspects in the robbery at Diamond
 Palace Jewelry and Pawnshop and Elle Jewelry

Creation, both business occupants in Gaisano Grand Mall, Tagum City at about 7:45 PM of February 18, 2011 that carted away undetermined amount of jewelries. Victims and witnesses of the incident positively identified him as the person who pointed with cal .45 pistol and immobilized them inside the Mandarin Tea Garden located at the ground floor of the Gaisano Mall while his companions were divesting the valuable items of said jewelries store.

• While the team is on the way to Davao del Norte PPO after arrested Christopher LLEDO, suspect revealed that the group has eight (8) members, three (3) of them were known to him as Clifford M. CENIZA, driver of Honda XRM color black get away motorcycle, and a resident of Poblacion Mabini, Comval Province, Marcelo LLENA y Lumanso @ Eloy, Planner of the group and former resident of Poblacion Mabini, Comval Province, and @ Dingdong VILLADARES as look out at Elle Jewelry Creation robbery and a resident of Calinan, Davao City, while the other four (4) companions were not familiar to him since @ Eloy brought them during the actual execution of the plan and imported from Ozamis City, Misamis Occidental Province.

• With the above information, the team proceeded back to Mabini, Comval Province covered with alias Warrant of Arrest docketed in CCNo. 14219 for the crime of highway robbery issued by Hon. Danilo Belo, Judge of



RTC Branch 31, Tagum City and arrested Clifford M. CENIZA. Said arrested person was brought to Davao del Norte PPO for further investigation. The team proceeded also to Calinan, Davao City to track down the whereabouts of Dingdong VILLADARES and Marcelo LLENA but said suspects were no longer in the above-mentioned place.

 Background check conducted by this Group to Christopher LLEDO and Clifford CENIZA revealed that they were involved in a series of criminal cases in Davao del Norte and Comval Province, to wit:

• Cases for Robbery with Violence against/or Intimidation of Persons were filed against the suspects before the City Prosecution Office docketed under IS Nos. XI-09-INQ11B-00026, XI-09-INQ11B-00027 and XI-09-INQ11B-0028. After filing of the case the two (2) suspects Christopher LLEDO and Clifford CENIZA were committed to Tagum City Jail, Tagum City.

4. NEUTRALIZATION OF PRIVATE ARMED AND CATTLE RUSTLING GROUP LEADER IN GAMU, ISABELA

On February 4, 2011, elements of Isabela CIDT-2RCIDU of

this Group together with Isabela Police Intelligence Section and 1st Maneuver Platoon-PPSC raided the hideout of suspected cattle rustlers/PAGs at Brgy. Guibang, Gamu, Isabela that resulted to the death of Erwin AQUINO @ Erong, principal suspect in the shooting to death of PINSP JELOWIE ANTONIO and PO3 Jaime Manaligod, both members of Police Intelligence Section-IPPO on June 8, 2010 at Brgy. Union, Gamu, Isabela.



• Erwin AQUINO @ Erong is a long wanted for a series of Murder and other crimes and identified as the alleged leader of a Private Armed Group of Gamu Mayor Fernando CUMIGAD. Subject is also the leader of a cattle rustling group operating in the province. During the operation, SPO2 Roveille Laggui of 1st Manuever Platoon of the PPSC was shot during the brief gun battle was pronounced DOA when brought to Isabela Doctors General Hospital in Ilagan, Isabela. Likewise, seven (7) persons who were believed to be butcher/helpers of the group at their hideout were invited and brought to Isabela PPO for investigation. Recovered from the crime scene were the following pieces of evidence:



- One (1) Ingram cal .9mm pistol with SN: 522101;
- One (1) cal .38 Smith and Wesson revolver; and
- One (1) cal .357 with defaced serial number.

 Cases for Murder and violation of PD 533 (Anti-Cattle Rustling Law) were filed against the suspects before the Provincial Prosecutor's Office, Ilagan, Isabela docketed under NPS Nos. II-04-INQ-00008 and II-04-INQ-00009, respectively.

5. NEUTRALIZATION OF A ROBBERY/HOLD-UP GROUP

 On January 30, 2011, elements of Bulacan CIDT-3RCIDU of this Group together with Bulacan Police Station encountered a robbery/hold-up group at Sitio Balubaran, Brgy. Duhat, Bocaue, Bulacan that resulted in the killing of three (3) suspects identified as Allan BLAS y Paradora, Jeffrey BULACLAC and one (1) unidentified suspect, and the recovery of the following pieces of evidence:



- One (1) cal .38 revolver with markings "S & W" Springfield without SN loaded with two (2) fire cartridge cases and four (4) live ammunition;
- One (1) cal .38 revolver with markings "S & W" Magnum loaded with six (6) live ammunition;
- One (1) cal .38 revolver with markings "world MPC", Lapu-lapu, 38 Special "CTG" with SN: 778426 with two (2) fire cartridge cases and four live ammunition;
- One (1) hand grenade;
- One (1) fired bullet;
- Six (6) cal .45 fired cartridge cases;
- Eight (8) cal .9mm fire cartridge cases;
- One (1) Honda XRM 155CC Motorcycle without PN;
- One (1) Nokia 1209 cellphone with sun cellular sim;

- One (1) Nokia 1650 cellphone without sim card; and
- Php 870.00 cash money.

• The said group identified as Allan Blas Robbery/Hold-up group headed by Allan BLAS operates in the cities of Meycauayan and San Jose Del Monte and municipalities of Bocaue, Balagtas, Marilao and Sta. Maria, all in Bulacan province. Prior to the said encounter, said group held-up the Media Eatery located at the MacArthur Highway, Brgy. Bunlo, Bocaue, Bulacan on January 29, 2011 at about 9:50 in the evening.

6. NEUTRALIZATION OF GUMBAY KFR GROUP IN GENERAL SANTOS CITY

• On January 10, 2011, elements of 12RCIDU of this Group together with GSCPO, JTF GENSAN and MIG 12 conducted operation in front of CPSC COMPAC, National Highway, Brgy. Apopong, General Santos City that resulted in the interception of one (1) Mitsubishi Van color gray bearing Plate No. MBH-138 and the arrest of three (3) malefactors on board identified as Jomar GUIAMAT; Mohalidin BAGUILAN; and Teng SIPE and seizure of the following pieces of evidence:

- One(1) cal .45 pistol bearing SN 092858;
- Seven(7) rounds of ammunition for cal .45; and
- One(1) piece steel magazine for cal .45



• Thereafter, a follow up operation by said team at National Highway, Purok San Vicente, Brgy. Labangal, General Santos City led to the arrest of another four (4) cohorts identified as:

- Abdullah SALIDATU @ Sammy @ Samir ABDULLAH@ Samad KINDAT@ Kamad DIMALEN alleged suspect in the Kidnapping of businesswoman Maria Gracia Paras Eleuterio of Sto. Niño, South Cotabato sometime November 14, 2010;

- Musib INDAL @ "Musib";
- Randy ZAMORA @ Ustadz JACK, alleged trained bomber; and
- Abosama GUMBAY @ Tong @ Datu Sultan TUNGAL@ Sultan Tong GUMBAY, allegedly was the leader of the group for kidnapping activities.
- The following pieces of evidence were confiscated:
 - Two(2) pieces Fragmentation Hand Grenades;
 - One(1) Colt M16 rifle with SN: RP177171;
 - One(1) Smith & Wesson cal Magnum .357;
 - One(1) improvised 12-Gauge pistol;
 - Eleven (11) rounds of ammunition for cal .45;
 - 130 rounds of ammunition for M16;
 - One(1) piece black bandolier; and
 - Five (5) pieces short plastic magazines for M16 rifle;

 Acase for violation of PD 1866 as amended by RA 8294 was filed against the arrested suspects before the City Prosecutor's Office, General Santos City docketed under NPS No. XII-03-INQ-11A-00016.

7. ARREST OF MEMBERS BOLT CUTTER/ROBBERY HOLD-UP/AKYAT-BAHAY GANG IN CALOOCAN CITY

 On January 4, 2011, elements of NMMCIDT-NCRCIDU of this Group conducted operation along Gen. San Miguel Street, Sangandaan, Caloocan City that resulted in the arrest of two (2) members of the notorious Bolt Cutter/Robbery Hold-up/Akyat-Bahay Gang identified as:



- Romeo ESTRIBA y Ramirez @ Romy, 41 years old, a resident of 10th Street, Urbano Subdivision, Novaliches, Quezon City; and
- David BORNO y Jose @ Jun, 35 years old, a resident of Brgy. Pasong Buwaya, Molino, Cavite.

 Arrested suspects are members of an eight-man gang who were responsible for the series of robbery/akyat-bahay incidents in NCR and nearby provinces including Rizal, Laguna, Cavite, Batangas and Bulacan by way of forcibly destroying the padlocks of the residences/establishments of their using bolt cutter. Other gang members who managed to elude arrest were identified by their aliases as Henry, Dodong, Jeff, Momoy, Amang and Jess. These suspects work alternately in two (2) groups. Recovered from the arrested suspects were the following:

- One (1) Bolt Cutter;
- One (1) cal .45 pistol bearing SN: 122768 with one (1) magazine loaded with eight (8) rounds of ammunition;
- Two (2) cal .38 revolvers each loaded with six (6) rounds of live ammunition in their cylinders;
- One (1) 12-gauge shotgun with markings Shooters and defaced serial number and with ten (10) rounds of ammunition;
- One (1) roll of packing tape and one (1) roll of scotch tape; and
- One (1) set of gloves.

• Likewise, one (1) unit Toyota Vios model 2010 colored silver gray with license plate number PUO-362 was also recovered from the arrested suspects which is the same motor vehicle tagged by informant as being utilized by the gang in their nefarious activities. Verification made with the Land Transportation Office showed that the above described motor vehicle is registered to one John Alex Ruiz y Castro of No. 125-8th Street, 12th Avenue, Caloocan City.

A case for violation of PD 1866 as amended by RA 8294 was filed against the arrested suspects before Inquest Prosecutor Darwin Canete of Caloocan Prosecutor's Office docketed under IS No. MOXV-02-INQ-11A-00045-46 who recommended Php 80,000.00 and Php 60,000.00 bail for Romeo ESTRIBA and David JOSE, respectively.

Maria, Judge of RTC Branch 145, Makati City for the crime of Kidnapping-for-Ransom that resulted to the arrest of Sgt. Salik Mindo ASIM @ Reynaldo Peralta MENDOZA/ @ Dhats/ Sgt. Edward SOLANTI, 40 years old at the vicinity of



Bulwagan ng Katarungan, Magsaysay Boulevard, Tacloban City.

• Subject person was re-arrested after posting bail in another case, for he was earlier apprehended by members of RID, Leyte PPO, HPG and Sta. Fe MPS on March 25, 2011 in Sitio Biasong, Sta. Fe, Leyte for violation of RA 8294 and RA 9165. The identification of the subject by the joint apprehending teams is substantiated by an affidavit of witnesses who knew him personally and he was assisted by his counsel Atty. Rogelio Bato all throughout in the conduct of interview.

• Likewise, he is included in the list of Most Wanted Persons (MWPs) with DILG approved monetary reward amounting to Php 250,000.00 under Memorandum Circular Nos. 2008-09. Moreover, subject arrested person was also positively identified and pinpointed by one of his group member whom he recruited last November 2010 in Tudela, Camotes, Cebu who later turned state witness as their leader, planner and organizer and stated among others that their crime group is responsible in numerous Robbery/Hold-Up incidents and other atrocities that happened in our AOR, which includes the Robbery of New Glory Copra Buyer that transpired on February 5, 2011 at around 8:00 o'clock in the morning along Lopez Jaina Street, Tacloban, City.

2. ARREST OF NO. 27 MWP IN REGION 5

On March 28, 2011, elements of Camarines Sur CIDT-

5RCIDU of this Group implemented Warrants of Arrest in CC No. 2808 issued by RTC Branch 33, Camarines Sur; CC No. 3543 for Robbery issued by Hon. Lore R. Valencia-Bagalasca, Judge of RTC Branch 56, Libamanan, Camarines Sur; CC No. 96-200239 for Murder issued by RTC Branch 28, Naga City; and CC No. 95-5705 for Murder issued by Hon. Marino A. Bodia, Judge of RTC Branch 26, Naga City that resulted to the arrest of Juanito ONA y Masalunga @ Totoy at Bingo Hall of SM



City, Brgy. Triangulo, Naga City. Suspect is listed as No. 27 Most Wanted Person in Region 5 for 2nd Quarter 2010.

Andal, Presiding Judge of RTC Branch 27, Tandag, Surigao del Sur for the crime of Murder that resulted to the arrest of Rosito SALAZAR y Gardigo @ Julitol, 41 years old at Brgy. Dawis, Tandag, Surigao del Sur. Suspect is listed as No. 13 Most Wanted Person in the Province of Surigao del Sur.



4. ARREST OF MAGUINDANAO MASSACRE SUSPECT

On March 16, 2011, elements of ARMMCIDU of this Group

together with Maguindanao PPO implemented Warrant of Arrest in CC Nos. Q-09-162148-72, Q-09-162216-31 and Q-10-162652-66 issued by Hon. Jocelyn A. Solis-Reyes, Presiding Judge of RTC Branch 221, Quezon City for the crime of Multiple Murder that resulted to the arrest of Tumi Timba ABAS @ Guiamil at Brgy. Awang, Datu Odin Sinsuat, Maguindanao.

 Suspect is listed among the Most Wanted Person involved in the gruesome Maguindanao Massacre on November 23, 2009 with monetary reward of Php 250,000.00 pursuant to



DILG Memo Circular No. 2010-53 dated June 29, 2010.

5. ARREST OF NO. 1 MWP IN SARIAYA, QUEZON

On March 16, 2011, elements of Quezon CIDT-4ARCIDU of this Group together with Sariaya MPS implemented Warrant of Arrest in CC No. 2006-815 issued by Hon. Bienvinido A. Mapaye, Judge of RTC Branch 55, Lucena City for the crime of Murder that resulted to the arrest of Jemar GOLLENA y Garilao, 36 years old at Brgy. Bucal, Sariaya, Quezon. Suspect is listed as No. 1 Most Wanted Person in the Municipality of Sariaya, Quezon.




6. ARREST OF PIONEER MEMBERS OF RAJAH SOLAIMAN MOVEMENT (RSM)

 On March 14, 2011, elements of NCRCIDU of this Group and CTD-IG together with Mandaluyong City Police Office implemented Warrant

of Arrest in CC No. 135738 issued by Hon. Abraham B. Borreta, Judge of RTC Branch 154, Pasig City for the crime of Murder and Multiple Frustrated Murder that resulted to the arrest of Ricardo AYERAS Perez @ У Abdulkarim/Abdulkareem at the vicinity of Mandaluyong City Medical Center, Boni Avenue, Mandaluyong City.

• The warrant of arrest was issued against the suspect for his alleged involvement in the Awang Airport Bombing in



Cotabato City on February 20, 2003. Subject is reported to be one of the pioneer members of the Rajah Solaiman Movement (RSM). In the early part of 2002, he attended a para-military training at the RSM Training Camp in Anda, Pangasinan. The subject eluded arrest when joint police and military troops raided the Anda Training Camp on May 1, 2002 as he was then on vacation.


 Sometime in year 2003, Ayeras along with other members of RSM identified as Pio DE VERA, Feliciano "Abubakar" DELOS REYES and Ibrahim KESSEL @ Abu MUJAHEED underwent military training conducted by MILF in Liguasan Marsh, SK Pendatun, Maguindanao. Their trainers were MILF members Abdulamanap MENTANG and Jabide ABDUL @ Bedz/Beze.

In the early part of 2005, the subject was personally chosen by RSM leader Hilarion "Ahmad" SANTOS (now serving sentence at NBP in Muntilupa) to conduct a bombing operation in Metro Manila whose target was being frequented by foreigners particularly Americans. The operation was not carried out because of mounting police operations against their group.

7. ARREST OF NO. 1 AND 2 MWP IN QUEZON PROVINCE

On March 11, 2011 at about 5:30 P.M., elements of Quezon CIDT-4ARCIDU of this Group together with Quezon PPO, PIB and Quezon PPSC implemented Warrant of Arrest in CC No. 2008-1028 issued by Hon. Virgilio C. Alpajora, Executive Judge of RTC Branch 59, Lucena City for the crime of Murder that resulted to the arrest of Michael BISCOCHO y Rubia, 26 years old at Brgy. Lutucan, Sariaya, Quezon. Subject person is listed as Most Wanted Person in National Level for Media killing.

• Likewise, at around 11:50 P.M. of same day, Mario BISCOCHO y Rubia, 46 years old, brother and co-accused of Michael BISCOCHO was also arrested at Brgy. Montecillo, Sariaya, Quezon by virtue of the same order of arrest.



For the period in review, the different operating units of the Group took cognizance of **595** cases, **159** or **26.72%** of which are Index Crimes while **436** or **73.28%** are Non-Index Crimes. Five hundred eighty-four (584) cases were filed in court, while eleven **(11)** are under investigation. The Group has a **Case Solution Efficiency (CSE)** of **98.15%**.

On the investigation of heinous crimes, the Group investigated fifty-six (56) heinous crimes, fifty-four (54) of which were filed and solved, while two (2) cases are still under investigation, registering a Crime Solution Efficiency (CSE) of 96.42%. Likewise, on the investigation of sensational cases, twenty(20) cases were investigated, fifteen (15) of which were filed/solved while five (5) are still under investigation, registering a CSE of 75.00%.

Buting, Pasig City that resulted to the arrest of two (2) vendors identified as Rodelio BOFILLEN y Bedion, 21 yearsoldand Rowell ROSCONIO y De Vera, 27 years oldand the confiscation of two hundred twenty-four (224) pieces of assorted pornographic DVDs with estimated market value of Php 7,500.00.

• A case for violation of Article 201, para 3 of the RPC was filed against the arrested vendors before the City Prosecutor's Office, Pasig City docketed under IS No. XV-14-INQ-11C-00191.

4. ARREST OF MARKET VENDOR SELLING PORNOGRAPHIC MATERIALS IN SESSION ROAD, BAGUIO CITY

 On February 22, 2011, elements of CARCIDU of this Group conducted operation against rampant selling of pornographic materials at Session Road, Baguio City that resulted to the arrest of Saiban ALI y Pangandamen, 36 years old and the confiscation of three hundred thirty-seven (337) pieces of pornographic DVDs/VCDs.

 On February 2, 2011, elements of Masbate CIDT-5RCIDU of this Group together with Aroroy MPS conducted operation at Public Market, Poblacion, Aroroy, Masbate that resulted to the confiscation of one hundred eight (108) pieces of obscene/pornographic DVDs/VCDs and the arrest of Minase SULTAN, 20 years old and Amber SADIR, 39 years old, who were both caught in the act of selling said confiscated items in public.

Significant accomplishments under CIDGOPLAN "Pagsisikap":

1. ENTRAPMENT OPERATION AT NAIA TERMINAL 2 ARRIVAL AREA, PASAY CITY

• On March 4, 2011, elements of ATCD of this Group conducted entrapment operation at the pre-arranged pay-off area located at Ninoy Aquino International Airport, Terminal 2 Arrival Area, Pasay City that resulted to the arrest of Verna Navidal LOMBO @ Ronica N. LOMBO, 42 years old after receiving Php 1,000.00 marked money.

• The operation stemmed from the complaints of Mrs. Janet M. Kim, Rowena Tan, and Hazel Tan who were recruited by the respondent and promised them a job as waitress, Human Resource Officer and Hotel Staff at Carlton Hotel, Sharjah, United Arab Emirates.

• After the complainant paid the required medical and placement fees, suspect's promise of deployment to Janet M. Kim did not materialize. However, complainants Rowena Tan and Hazel Tan landed at UAE on November 7, 2010 but the promised job did not existed. Hence, they return to the Philippines on January 27, 2011 and shoulder their plane ticket expenses.

• Cases for violation of RA 8042 as amended by RA 10022 (Migrant Workers and Overseas Filipino Act of 1995) and Article 315 of the

Revised Penal Code (Swindling) were filed under NPS Docket No. XV-13-INQ-11C-00324.

2. ENTRAPMENT OPERATION IN MANDALUYONG CITY

 On March 3, 2011, elements of ATCD of this Group conducted entrapment operation at inside the house of the complainant located at H-12, RSG-1, Calbayog Street, Mandaluyong City that resulted to the arrest of Ramon CAMU y Rodriguez, 52 years old after receiving marked money.

Investigation conducted disclosed that sometime on February 4, 2011, complainant Wilfredo Villarosa Zaspa was recruited by the suspect in his house. The suspect introduced himself as Chief Mate of an International Shipping Vessel and having the legal capacity to recruit and deploy seamen abroad. Suspect enticed the complainant to apply to for a job as Overseas Electrician/Seamen and promised him to receive US\$ 2,700 per month as salary under ten (10) months contract, Suspect also required the complainant to undergo five (5) various seaman training prior to his deployment and likewise asked him to submit documents such as original Passport and photocopy of his birth certificate. Complainant gave the suspect the initial amount of Php 8,500.00 to cover for the expenses in procuring the Training Certificate and payment for Panama Boarder Registry.

 However, complainant found out that suspect has previous charges at RTC Branch 211 under CC No. MC05-9078 for violation of RA 8042. Likewise, initial verification made with the POEA revealed that the suspect is not authorized to recruit and deploy workers abroad.

• Cases for violation of RA 8042 as amended by RA 10022 (Migrant Workers and Overseas Filipino Act of 1995) and Article 315 of the RPC (Swindling) were filed against the arrested suspect before the Office of the Assistant City Prosecutor Romualdo V. Francisco, City Prosecutor's Office, Mandaluyong City docketed under NPS No. XY-06-INQ-11C-00145.

3. ARREST OF A BRITISH NATIONAL IN TAYTAY, RIZAL

• On February 24, 2011, elements of NCRCIDU of this Group conducted entrapment operation along Bayabas Street, Aurora Subdivision, Muzon, Taytay, Rizal that resulted to the arrest of Ramanasaijeeswaran KANAGALINGAM @ Warren KANAGA, 41 years old, British National of Sri Lankan descent, holder of United Kingdom of Great Britain and Northern Ireland Passport No. 800110547 and temporary residing at Lot 5, Block 4, Home at Last Subdivision, Muzon, Taytay, Rizal based on the complaint of Jeffrey E. Gabuay and two (2) others for violation of RA 8042 and Article 315 of the RPC.

4. ENTRAPMENT OPERATION AT KFC FOOD CHAIN IN EAST AVENUE, QUEZON CITY

• On February 1, 2011, elements of ATCD of this Group conducted entrapment operation inside the KFC Food Chain located at East Avenue, Quezon City that resulted to the arrest of Mildred Medalla CONCEPCION, 36 years old, a resident of Block 6, Lot 3, Palmera Spring Subdivision, Camarin, Caloocan City.

The operation stemmed from the complaint of Yoshiko ODA and eight (8) others who were recruited and promised by the respondent of an overseas job at Qatar as cashier, waitress and kitchen helper with a promised salary ranging from Q1,800.00 to Q2,500.00 Riyals. However, the applicants after submitting required documents, paying the required fees and four (4) months of waiting for their deployment the suspect failed to deploy them. Sensing that were victimize by the suspect, they lodge their complaint to the POEA and was subsequently referred to ATCD of this Group for investigation.

• A case for violation of RA 8042 (Migrant Workers and Overseas Filipino Act of 1995) was filed against the arrested suspect.

5. ENTRAPMENT OPERATION AT PAN CAKE SM NORTH EDSA, QUEZON CITY

 Accordingly, on August 5, 2010, complainant met suspect Mary Ann KASSEM thru @ Noly (TNU) at Pizza Hut, SM North, Quezon City and told her that she has a recruitment agency named Active Employment Agency and Juvial Employment Agency and promised to send her to Dubai to work as waitress. Suspect asked for her passport for processing of her visa and assured her that after twenty-five (25) days she can leave for Dubai.

• After 25-day, complainant asked the suspect about her Visa and the scheduled flight but suspect keeps on promising and making alibis as to the delay of the release of her visa until complainant lost interest and instead asked for the return of her passport. However, the suspect demanded Php 15,000.00 for the release of said passport. Verification made with the POEA revealed that said agency is not licensed to recruit workers for overseas employment.

• A case for violation of RA 8042 (Illegal Recruitment) and Robbery/Extortion were filed against the arrested suspect before the Quezon City Prosecutor's Office.

• The operation stemmed from the complaint lodged by Michelle M. RIVERO, 34 years old, married of Gold and Gems Jewelry Shop

located inside Theater Mall, Greenhills, San Juan City for violations of BP 22 (Bouncing Check Law); Article 315 (Estafa/Swindling) and Article 293 (Robbery/Extortion) of RPC.

Investigation disclosed that on several occasion from September 5, 2010 up to February 10, 2011, suspects went to the office of complainant and ordered assorted jewelries amounting to more or less Php 3Million. As payment in every transaction, suspects drew and issued postdated check, however, when the said checks were brought to drawee bank, it bounced by reason of "Closed Account".

• The operation was in response on the report from a concern citizen that an alleged illegal selling/peddling of medical drugs by unauthorized persons were rampant at the said area.

 Acase for violation of RA 5921 (An Act Regulating the Practice of Pharmacy and Setting Standard of Pharmaceutical Education in the Philippines and for other Purposes) was filed against the arrested suspect before the City Prosecutor's Office, Urdaneta City, Pangasinan docketed under NPS Docket No. 1-11-INQ-11C-00017.

WEI, identifying himself to be a Dental Director/Administrative Services of Robinsons Development Corporation, allegedly with office address at Robinsons Tower, Pala-Pala, Dasmariñas, Cavite concerning the purchase of fifteen (15) boxes of Box CERAM X Duo 7 Syringe Kit dental supply Php 293,130.00 from Fildent Trading with office address at Unit 10 French Classic Homes, 1785 E. Rodriguez Avenue, Cubao, Quezon City for allegedly issuing a misrepresented company check.

Cases for violation of Article 315 (Swindling/Estafa) in relation to BP Blg. 22 as amended by PD 818 (Increasing penalty in the issuance of Bounced Checks) and violation of RA 6085 (An Act Amending Commonwealth Act Numbered One Forty-two regulating use of Aliases) were filed against the arrested suspect before Asst. City Prosecutor Maria Roma A. Ortiz of Manila Prosecutor's Office docketed under IS No. INQ-11B-01543-44.

4. OPERATION AGAINST BOYS OF BORA SPA IN SIKATUNA VILLAGE, QUEZON CITY

• On February 18, 2011, elements of NCRCIDU of this Group together with GMA 7 TV segment Imbestigador conducted entrapment operation

at Boys of Bora Spa located at No. 141 B. Kamias Road, corner Anonas Street, Sikatuna Village, Quezon City that resulted to the arrest of Darwin SAIN y Barrameda, 22 years old and Wally SIMEON y Villarba, 27 years old, both Therapist and stay-in of said establishment, who were caught in the act totally nude masturbating to both GMA confidential informants who acted as poseur customer. Recovered from the arrested suspects was marked money used as payment for the extra services they rendered.

• Likewise, Eric SANTIAGO y Sulay, 41 years old, the alleged Owner/Proprietor of Boys of Bora Spa and thirteen (13) Therapists at the said establishment were subsequently arrested when they failed to present their valid working and health permits when requested to present the same.

• Arrested suspects were inquested before Assistant City Prosecutor Vesta Victoria Giner-Villamor of City Prosecutor's Office, Quezon City with the recommendation that Darwin SAIN and Wally SIMEON be charged for violation of Article 202 (Prostitution), while the fourteen (14) other suspects/therapists were charged for violation of City Ordinance No. 10-700 (Working without Valid Permits). The recommended bail for their temporary liberty was fixed at Php 2,000.00 each.

5. ARREST OF SUSPECT FOR ILLEGAL DENTAL PRACTICE IN GEN. MARIANO ALVAREZ, CAVITE

• On January 20, 2011, elements of Cavite CIDT-4ARCIDU of this Group conducted entrapment operation at Brgy. Poblacion, Gen. Mariano Alvarez, Cavite that resulted in the arrest of Rosemarie SALAZAR y Sta. Ana, 44 years old, a resident of No. 106, Block 18, Lot 4, Brgy. Poblacion, GMA, Cavite.

Prior to the arrest, on January 19, 2011, Dra. Mary Eleanor Sta. Cruz-Lee, Chapter President, Cavite Dental Association together with Dr. Reynaldo Garcia and Dr. Ferdinand Reyes, Chairman and Vice-Chairman, respectively of the Legal Affairs, Philippine Dental Association accompanied by Mr. Dandy Alandy, Segment Producer of GMA News and Public Affairs appeared before the Cavite CIDT Office to report the alleged illegal dental practice of Rosemarie SALAZAR.

 Investigation showed that the respondent had been performing illegal dental practices since 1998 at Gen. Mariano Alvarez, Cavite. Accordingly, the respondent has been previously warned by the PDA to refrain from performing said illegal activity to various clients and patients since she was not authorized to do so by the law.

• A case for violation of Section 33, para (a) and (i) of RA 9484 (Philippine Dental Act of 2007) was filed against the arrested suspect before the Provincial Prosecutor's Office, Imus, Cavite docketed under IS No. IV-03-INQ-11A-0240.

6. OPERATION AGAINST CYBER SEX DEN IN DINALUPIHAN, BATAAN

• On January 10, 2011, elements of Bataan CIDT-3RCIDU of this Group together with Bataan PPSC implemented Search Warrant No. 338-10 issued by Hon. Remigio M. Escalada Jr., Executive Judge of RTC Branch 3,

Balanga City, Bataan that resulted in the arrest of Alvin LAZO, Shift Manager; Catherine Joy DELA CRUZ, Operation Manager; Roxanne TALA; Lito GUARO, both Supervisors and thirty-two (32) chat sales agents at Midway 635 Contact Center located at Bonifacio, Dinalupihan, Bataan owned by Albert ATIENZA.

 Said establishment disguised as a call center but is actually engaged in selling of pornographic sites through online chatting using yahoo messenger and iMesh applications. However, Albert ATIENZA was not around and nowhere to be found during the operation. Seized were the following pieces of evidence:

- Sixty (60) sets of computers;
- Three (3) hubs;
- Three (3) modems;
- Four (4) routers;
- One (1) Epson printer with scanner;
- One (1) printer; and
- One (1) unit of telephone landline (Globe).

• Cases for violation of Article 201 of the RPC, in relation to RA 8792 (Electronic Commerce Act), Section 9(j) and 9(o) (2) of RA 8484 (Access Device Regulation Act), and Section 4(e), 5(c) of violation of 9208 (Anti-Trafficking in Person Act of 2003) were filed against the arrested persons before the Provincial Prosecutor's Office, Balanga City, Bataan docketed under NPS No. III-03-INQ-11A-0008.

ADMINISTRATIVE ACCOMPLISHMENTS:

PERSONNEL MANAGEMENT

As of March 31, 2011, the Group has an actual strength of 1,221; registering a 63.46%, fill-up out of a 1,924 authorized strength. Of this number, 253 are Police Commissioned Officers (PCOs), 877 are Police Non-Commissioned Officers (PNCOs) and 91 are Non-Uniformed Personnel (NUP). Likewise, 8.05% of the uniformed personnel are assigned at HCIDG while 91.95% at the Regional Criminal Investigation and Detection Units and Special Operating Divisions. Based on the authorized strength of 1,924, CIDG has a percentage fill-up of 81.61% for PCOs, 58.86% for PNCOs and 73.39% for NUP.

With the end in view of enhancing the accountability and responsibility of all Regional Chiefs, Chiefs of Offices and field operating units, HCIDG took the following courses of action:

- a) ConductedGroup and Staff Conferences at the Headquarters, CIDG and attended by all Chiefs, Divisional and Special Staffs, Section Chiefs and Chiefs, SODs; and
- b) Approved, recommended to NHQ-PNP, and/or caused the issuance of orders for the assignments, reassignments and transfer of personnel.

REVIEW OF POLICE DOCTRINE

To improve the efficiency and performance of personnel and check violations of regulations and Police Operational Procedures, the following reforms were introduced:

a. Maintained and proper dissemination to personnel of Headquarters, RCIDU's and SOD's of the Group, the directives, memoranda and circulars emanating from higher headquarters;

b. Reiteration and dissemination of copies of the Police Operational Procedures and Commanders Manual to be used as guidance in the conduct of any police operation in regional/provincial units and divisions;

c. Conduct of Monthly Ranks Inspection, PI & E and Physical Fitness Sports Development to all personnel of the Group; and

d. Review of the existing SOP's to improve coordination with PNP territorial units and other law enforcement/government agencies.

INTELLIGENCE ACCOMPLISHMENTS:

The Group conducted eleven(11)Security Survey Inspections (SSI's), recorded **320**Summaries of Information (SOI's), provided five (5) VIP security operations and intelligence coverage and prepared nine (9) COPLAN's against Organized Crime Groups, Criminal Gangs and Most Wanted Persons.

On the implementation of **OPLAN MAGIC EYE II**, the Group identified and investigatedsix hundred thirty-seven **(637)** PNP misfits.

The Group also prepared **170** periodic intelligence reports (WIR/MIR) and intelligence summaries. Thirty-five **(35)** cases involving foreign nationals were also investigated, sixty-seven **(67)**intelligence conferences/meetings/seminars were attended.

CONCLUSION:
