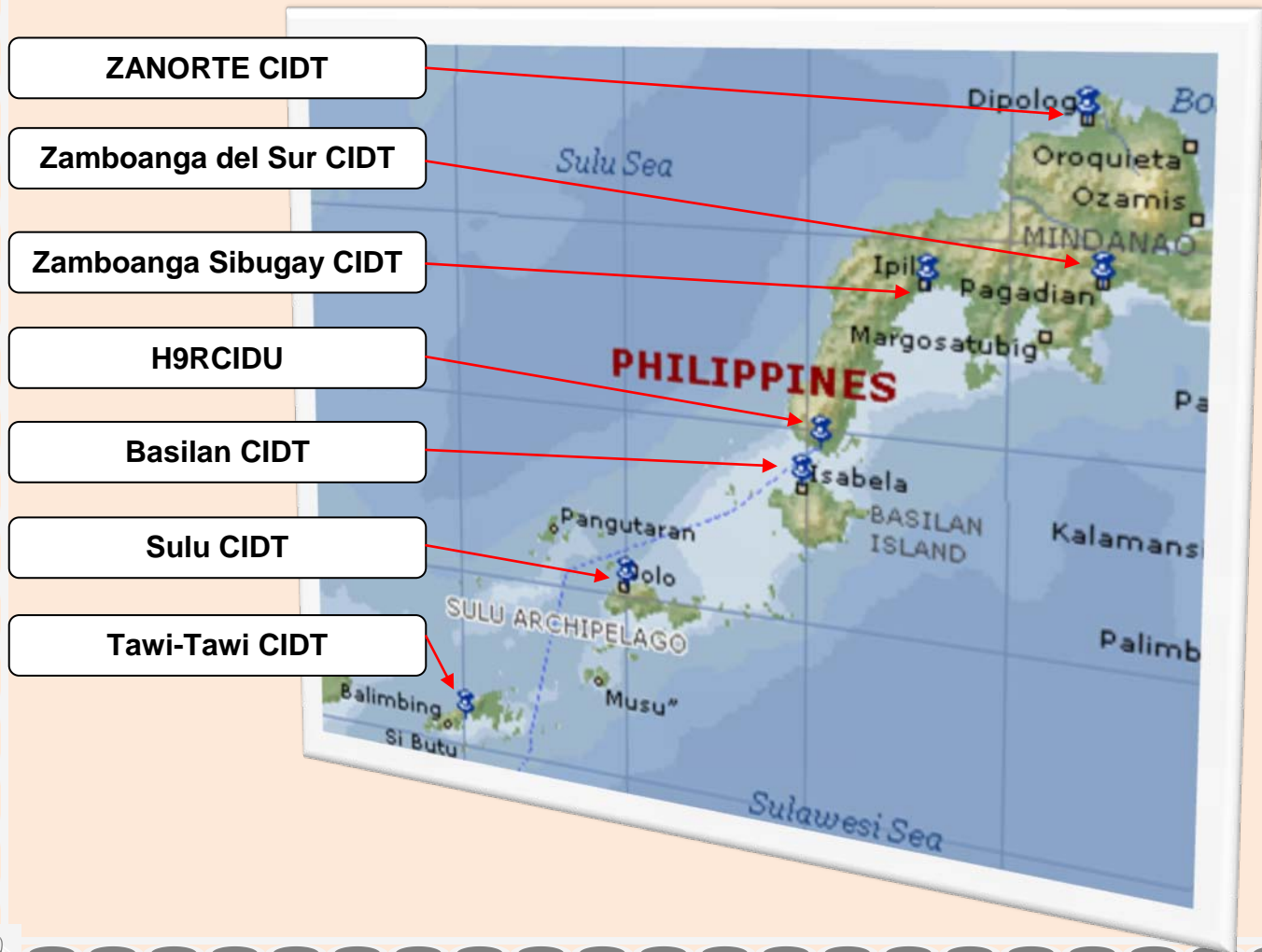

Judge Tibing Asaali of RTC Br. 17, 9th Judicial Region, Zamboanga City while a case for Grave Threat was filed against Jamah Mocaddam and Damsan Henio docketed under **CC# 49101** issued by Hon. Ivan C. Mendoza, Jr, Vice Executive Judge of MTCC, Zamboanga City repectively.

As a result, charges for violation of RA 8294 and COMELEC Omnibus Election Code was filed before the Ipil Provincial Prosecutors Office thru Inquest Proceeding docketed under CC# I-4509 and I-4510.

Zamboanga City by personnel of this office and Basilan CIDT by virtue of Warrant of Arrest for the crime of Murder and Multiple Frustrated Murder docketed under CC# 4865-1822, 4868-1823, 4869-1824, 4870-1825- 4871-1826 and 4873-1827 respectively issued by Hon. Judge Danilo M. Bucoy of RTC Br. 2, 9th Judicial Region, Isabela City, Basilan. Subject person is now detained at Basilan Provincial Jail.

14. The arrest of **Jeany OCAMPO y Refugio**, 33 years old, a resident of Lower Turno, Dipolog City on June 29, 2010 at around 8:30 in the morning at Balintawak St., Brgy. Biasong, Dipolog City by personnel of ZDN-CIDT by virtue of Warrant of Arrest for ESTAFA under CC# 16383 issued by Hon. Judge Hipolito P. Bael of RTC Br. 6, Dipolog City. However, the subject posted cash bond in the amount of PPhp20,000.00 for her temporary liberty.

➤ Investigation of Heinous and Sensational Cases

• The kidnapping of Benjamin Almonte

On February 6, 2010 at around 9:00 in the morning, **Benjamin ALMONTE y Pangilinan**, 55 years old, retired Philippine Army and a resident of Sitio Busug, Brgy. Manicahan, Zamboanga City was abducted by unidentified suspects.

In the evening of February 19, 2010 after fourteen (14) days in captivity, the victim was released by his abductors and on February 20, 2010, police operation was conducted at Poblacion Kabasalan, Zamboanga Sibugay Province that resulted to the arrest of two (2) suspects identified as **Anzar SIBING y Yusop** and **Abraham IBNO y Amilussin**. Confiscated from their possession and control was one



(1) unit Cal. 45 Pistol CASPIAN bearing SN: 357218 with one (1) magazine assembly loaded with seven (7) live ammunitions and one (1) unit Cal. 38 revolver defaced serial number.

Charges for **Kidnapping with Serious Illegal Detention with Ransom, Illegal Possession of Firearms and COMELEC Omnibus Election Code** respectively were filed before the Zamboanga City Prosecutors Office thru Inquest Proceeding under CC# 24820.

- **Harassment at Brgy. Tubigan, Maluso, Basilan Province**

This is an aftermath of the harassment conducted by MILF led by Commander Talib Mutalib with more or less sixty (60) armed followers together with Dick Alaw, Usmani Alaw, Abduraup Alaw @ Elahan, Omar Alaw, Loy Abdulsali, Dadi Abdulsali, Amri Abdulsali, Kimar Akmadi, Jun Alaw, Omar Andihad, Ummal moro, CAA Amil Sali and Hassan Hussin who attacked the village of Brgy. Tubigan, Maluso, Basilan Province. The armed group fired upon their assorted high powered firearms towards the houses of innocent civilians wherein thirteen (13) were wounded and twelve (12) others were killed while eight (8) house were totally burned still perpetrated by the above-named suspects.



On March 5, 2010, charges for Multiple Murder, Multiple Frustrate Murder, Robbery in Band and Arson (8 counts) were filed before the Basilan Provincial Prosecutors Office docketed under I.S. Nos. XIV-02-INV-10C-0024 to 10C-0033.

- **Landmine explosion at Brgy. Kagay, Indanan, Sulu**

On September 29, 2009 at around 8:30 in the morning, a convoy of US Forces together with personnel of 26th Marine Company (MC), Marine Battalion Landing Team 6 (MBLT6), 3rd Marine Brigade (3MBDE) while on their way towards Marine Detachment located at Brgy. Bato-Bato, Indanan, Sulu was pounded by a landmine which resulted to the death of two (2) US Forces and one (1) from the Philippine Marines who were on board a Humvee Vehicle. The victims were identified as **SSG Jack Martin**, **SFC Christopher Shaw** and **PFC Jerwin J. Estrada**.



On March 8, 2010, a case for Murder (3 counts) was filed before the Jolo Provincial Prosecutors Office against **Commander Khaid Ajibon**, **Commander Ahadon Adak**, **Certain Commander Tahil**, **Commander Abraham Joel**, **Commander Jun Ajibon**, **Commander Kira Adain**, **Alias Mahan**, **Alias Radzmier**, **Salip Anwar**, **Pakpak Majid** and **Apah Kirah**, all affiliated with the **Moro National Liberation Front (MNLF)** operating in the Island Province of Sulu docketed under CC# 1119-4.

- **Kidnapping of Michael Tan, Oscar Lu and Mark Singson**

On November 10, 2009 at around 12:15 AM (dawn), unidentified armed men enter at Hi-Tech Woodcraft Industry Inc. located at Townsite, Maluso, Basilan Province and forcibly abducted three (3) employees of the said company identified as: . However, Witness Darwina Sawadjaan y Undang



implicating Mujahid Nasirin as among of the armed men responsible in the abduction of the above-named victims. As a result, personnel of Basilan CIDT arrested Mujahid Nasirin and filed a case for Kidnapping with Serious Illegal Detention before the Basilan Provincial Prosecutors Office docketed under I.S. # XIV-02-INV-10C-0038, 10C-0039 and 10C-0040 respectively against Mujahid Nasirin and several unidentified others.

- **Encounter and Explosion incident in Isabela City, Basilan**

This is an aftermath of the series of explosion and encounter incident that transpired on April 13, 2010 at around 9:45 in the morning at Isabela City Grandstand between the ASG members and the government forces wherein three (3) ASG members were killed and two (2) other wounded were captured identified as **Ajid Jainul and @ UMBAK**.



The enemy withdraw towards Brgy. Tabiawan passing through Theresa Heights, Brgy. Eastside and Sitio Isleta, Brgy. Binuangan, same city and keep on firing their guns towards innocent civilians and further engaged with personnel of G2, Philippine Marines.

The incident resulted to the killing of three (3) personnel from the Philippine Marines identified as: **PFC Francis Vibal, PFC Anastacio Giron and PFC Jerome Versola**, one (1) PNP identified as **PO1 Elmer Cajalne**, the wounding of **SPO4 Enrico Morales** and the killing of six (6) innocent civilians identified as: **1. Alberto Senibalo, 2. Edilberto Dela Luna, 3. Boy Francisco, 4. Van Nabi, 5. Rodelio Villa, and 6. Jayjay Laracochea**. Subsequently, on April 17, 2010, charges for Murder (10 counts) and Frustrated Murder was filed before the Isabela City Prosecutors Office docketed under I.S. No.



IX-04-INV-10D-00019 against **Puruji INDAMA, Nurhassan JAMIRI, Moton INDAMA, Ajid JAINUL, @ UMBAK, @ MOHAMMAD** and several John Does.

On April 13, 2010 at around 10:45 AM, a loud explosion occurred at the vicinity of Sta. Isabel Cathedral, located at Misericordia Street, Isabela City, Basilan. As a result, one (1) innocent civilian was killed while fifteen (15) others were injured. Charges for MURDER and Multiple Frustrated murder was filed before the Isabela City Prosecutors Office



against **Puruji INDAMA, Nurhassan JAMIRI, Moton INDAMA, Ajid JAINUL, @ UMBAK, @ MOHAMMAD** and several John Does docketed under **NPS Docket No. IX-04-INV-100-00020**.

- On May 30, 2010 at around 6:30 in the evening, one (1) Malik Usab was abducted by Patar Salahuddin, Boy Salahuddin and six (6) unidentified armed other companions at Akuk Sangkula, Brgy. Lupah Abu, Parang, Sulu. The victim was released on April 1, 2010 at around 4:30 in the afternoon at Brgy. Bato-Bato, Indanan, Sulu upon payment of ransom money in the amount of PHp470,000.00. Subsequently, on May 19, 2010, a case for Kidnapping with Serious Illegal Detention was filed before the Sulu Provincial Prosecutors Office against Patar Salahuddin, Boy Salahuddin and six (6) unidentified others under docket number NPS-XIV-07-INV-10E-00060.

- On May 27, 2010 at around 6:45 in the morning, abduction incident occurred at Sitio Munpol, Brgy. Lbug, Sumisip, Basilan wherein the victims identified as **Claudio Mañanita**, employee of Mangal Agrarian Reform Beneficiary Development Cooperative

(MARBEDCO), **Jofrey Mañanita, Rolando FRANCISCO and Daniel D QUINTELA** by the members of the Abu Sayyaf Group led by Puruji



Indama. However, on June 5, 2010 at around 10:00 o'clock in the morning, the three (3) kidnapped victims were already killed by their abductors at the boundary of Brgy. Sukaten and Brgy. Bacung, Sumisip, Basilan Province. Subsequently on June 18, 2010, charges for 2 counts Kidnapping with Serious Illegal Detention aggravated with Murder was filed before the Basilan Provincial Prosecutors Office against Puruji Indama and thirty (30) unidentified others docketed under I.S.# XIV-02-INV-10F-0057 to 58 respectively.

OTHER SIGNIFICANT ACCOMPLISHMENTS

➤ ANTI-KIDNAPPING

- **T**he kidnapping of **Benjamin ALMONTE y Pangilinan** on February 6, 2010 at around 9:00 in the morning at the sea water of Brgy. Manicahan, Zamboanga City and on February 19, 2010 after fourteen (14) days in captivity, the victim was released by his abductors. On February 20, 2010, manhunt operation conducted by joint elements of DIPO-WM, NISG, ZCPO, S2-ZSP-PPO, 9RCIDU and PNP-SAF at Poblacion Kabasalan, Zamboanga Sibugay Province wherein two (2) suspects identified as **Anzar SIBING y Yusop** and **Abraham IBNO y Amilussin** were arrested. Confiscated from their possession and control was one (1) unit Cal. 45 Pistol CASPIAN bearing SN: 357218 with one (1) magazine assembly loaded with seven (7) live ammunitions and one (1) unit Cal. 38 revolver defaced serial number.



Charges for **Kidnapping with Serious Illegal Detention with Ransom, Illegal Possession of Firearms and COMELEC Omnibus Election Code** respectively were filed before the Zamboanga City Prosecutors Office thru Inquest Proceeding docketed under CC# 24820.

- **T**he kidnapping of **CHARLIE REITH** 72 years old, married, naturalized Filipino and a resident of Valderosa Street, Zamboanga City on April 4, 2010 at around 6:20 in the evening at Brgy. Patalon, Zamboanga City. However, on June 16, 2010 after two (2) months and twelve (12) days in captivity, the victim



was successfully rescued by operatives of **Joint Task Force (JTF) Charlie** and **Joint Task Force (JTF) Trillium-Naval Forces Western Mindanao (NFWM)** at the shoreline of Brgy. Labuan, Zamboanga City. Manhunt operation conducted by joint operatives of the Intelligence Section-ZCPO and RID, PRO-9 at the shoreline of the boundary of Brgy. Sinubong and Brgy. Talisayan, this city that resulted to the killing of the alleged abductor a certain **IBNOKAIS** (TNU), a native of Brgy. Baiwas,



Sumisip, Basilan Province while his two (2) other companions were able to elude arrest. Recovered from the crime scene was one (1) unit Cal. 45 Pistol without brand name bearing SN: 760661. This case still under investigation due to unavailability of witness who could identify the suspect.

CAMPAIGN AGAINST PRIVATE ARMED GROUPS

AND LOOSE FIREARMS

- **O**n February 1, 2010 at around 11:30 in the morning, elements of ZSP-CIDT led by PCI PRUDENCIO G ENOJO JR., served the Search Warrant Nr. I-99 at the residence of Romeo Nares located at Purok Nangka, Veterans Village, Ipil, Zamboanga Sibugay Province which resulted to the recovery of one (1) unit Cal .45 Pistol, Norinco bearing serial number BA18439-08-246, three (3) empty magazines for caliber .45 pistol, ten (10) live ammunitions for caliber .45 pistol. However, the subject was able to present pertinent documents as to the legality to possess the said firearm.



- **T**he confiscation of one (1) unit Cal. 45 Pistol CASPIAN bearing SN: 357218 with one (1) magazine assembly loaded with seven (7) live ammunitions and one (1) unit Cal. 38 revolver defaced serial number on February 20, 2010 at Poblacion Kabasalan, Zamboanga Sibugay Province from the possession and control of **Anzar SIBING y Yusop** and **Abraham IBNO y Amilussin**. The suspects involved in the kidnapping of **Benjamin ALMONTE y Pangilinan** that transpired on February 6, 2010 at Sitio Busug, Manicahan, Zamboanga City.



Charges for **Kidnapping with Serious Illegal Detention with Ransom, Illegal Possession of Firearms and COMELEC Omnibus Election Code** respectively were filed before the Zamboanga City Prosecutors Office thru Inquest Proceeding under CC# 24820.

- **T**he confiscation of one (1) unit Cal. 45 pistol NORINCO SN: 685174 and one (1) magazine assembly for Cal. 45 on March 22, 2010 at around 9:00 in the morning along National Highway, Brgy. Veteran, Ipil, Zamboanga Sibugay Province from the possession and control of **Adjong Jimbong y Samsarani**. Charges for violation of RA 8294 and COMELEC Omnibus Election Code was filed before the Ipil Provincial Prosecutors Office thru Inquest Proceeding docketed under CC# I-4509 and I-4510 respectively.



OTHER LAW ENFORCEMENT ACTIVITIES

- **T**he arrest of **Jamah MOCADDAM** and **Damsan HENIO** on March 11, 2010 at around 3:00 in the afternoon at Mindpro Citimall, La Purisima St., Zamboanga City during the conduct of entrapment operation engaged in Robbery Extortion activity. Subject arrested persons were charged for Robbery Extortion and Grave Threat docketed under CC# 24825 and 49101 respectively.



- **O**n March 17, 2010 at around 12:50 in the afternoon, operatives of this Regional Unit conducted entrapment operation at Campaner Extension, Brgy. Zone 3, Zamboanga City that resulted to the arrest of one (1) **Dave Bajelot y Abao**, 24 years old, a resident of Thomas Claudio St., Zamboanga City.

Charges for Robbery Extortion and Grave Threat were filed thru inquest proceeding against **Dave Bajelot y Abao** before Zamboanga City Prosecutors Office docketed under CC# 49119.
