All the while I thought that ceramic making is being encouraged by the government, such as the ceramic program under NACIDA and other agencies of the government like SPDA. Why the problems of

Actually, many local industries, including ceramic making, are discouraged, for in many cases, the government is not giving full support. The agencies that are designated to help often stop the help due to budgetary problem. Annual budget often changes, and most of the time, it is reduced to minimum, hence, a laudable project(s) is stopped. The case in point is that of SPDA — if our information is correct, social

Pineapple exports up

CAGAYAN DE ORO CITY — (PNA) — The provinces of Misamis Oriental and Bukidnon continued to be the country's top pineapple producers, exporting more than eight million pesos worth of the fruits this year.

The Philippine bureau of standards (PBS) said as of November, some 3.8 million kilos of pineapple have been harvested in the two areas.

The exports include 7.5 million pesos standardized pineapple products broken as follows: 1,754,179 kilograms of fresh pineapple valued at 709,905 pesos;

2,445,770 kilograms of canned solid pineapples worth 6,454,106 pesos; and 251,701 kilograms of canned pineapple juice costing 390,604 pesos.

Also inspected by PBS were 339,675 kilograms of unstandardized canned pineapple valued at 540,686 pesos.

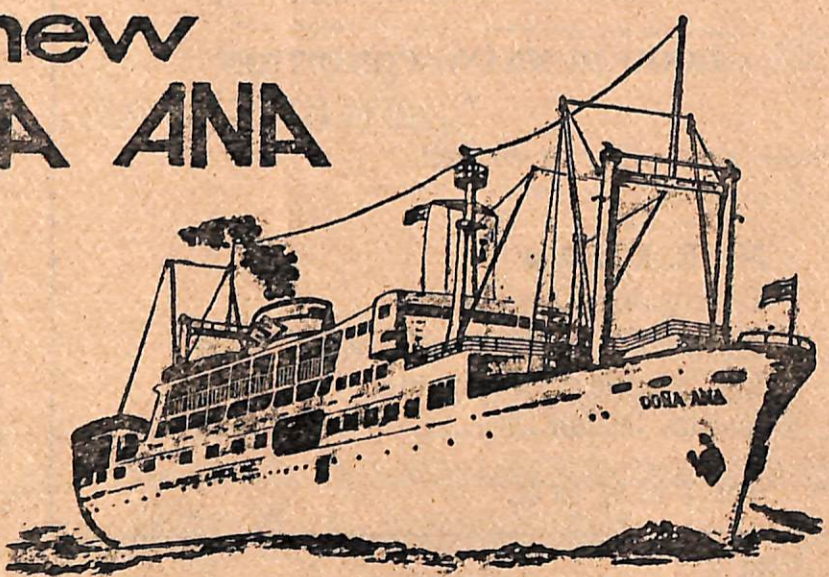
Other export products inspected by PBS last month were 618,710 pesos worth of Philippine veneer, 1,354,047 pesos worth of Sawaluaan lumber, and 175,200 pesos worth of sorghum haycubec animal fodder.
