The Trainers/ Inspectors shall have, but not limited to, the following duties:

1. review and evaluate submitted documents by the applicants;
2. set out the inspection plan, time frame and scope of inspection;
3. conduct actual inspections;
4. prepare inspection report;
5. coordinate with the applicant non-compliant items reflected in the inspection report and non-compliant form;
6. conduct follow-up inspections;
7. report the results of evaluation and findings to the GAHP Certification Committee; and
8. perform other tasks related to GAHP Certification/Inspection that may be assigned from time to time.



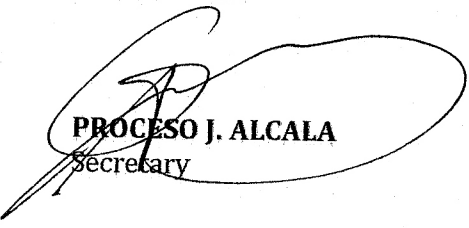
